Please note, that the terms **client**, **patient**, and **individual** are used interchangeably throughout this document depending on the nature of the feature.

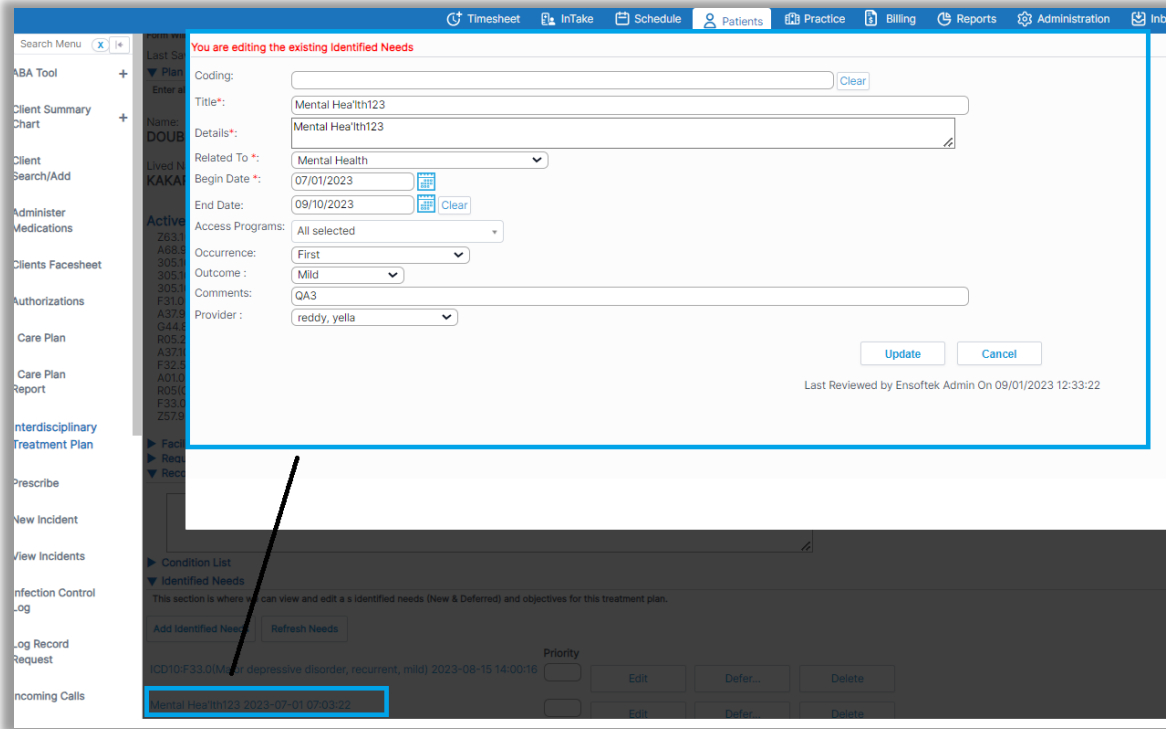

Core Setup

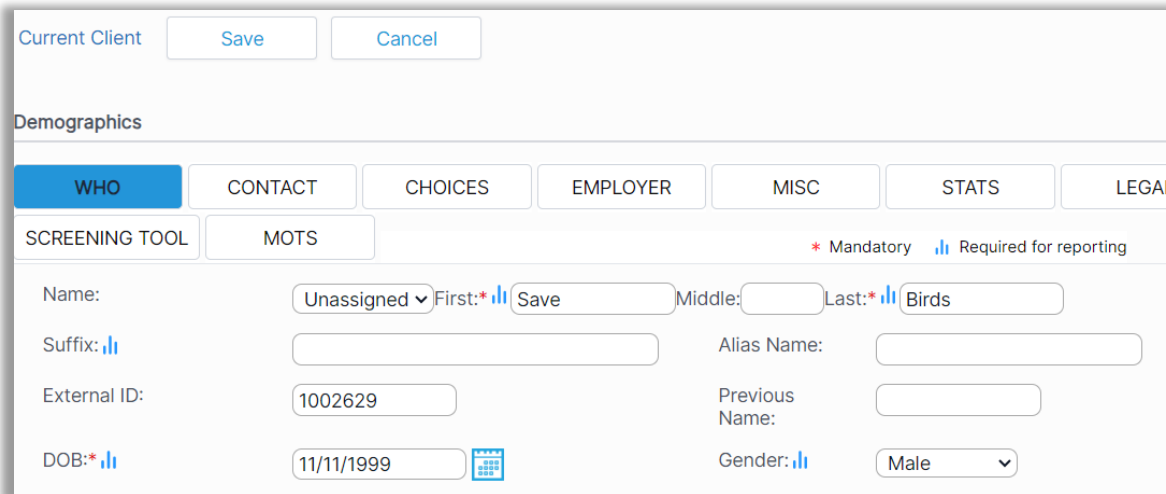
Now authorized users can click the Identified Needs hyperlink in the MDTP to start editing the Needs.

## New “Other Contacts” Data Type in Form Builder

Core Setup

Now authorized Form Builder Users can use the new “Other Contacts” widget under “Visit tools” in the Form Builder to add/update Other Contacts from within a Form Builder form.

In addition other contact information can also be included into the form.

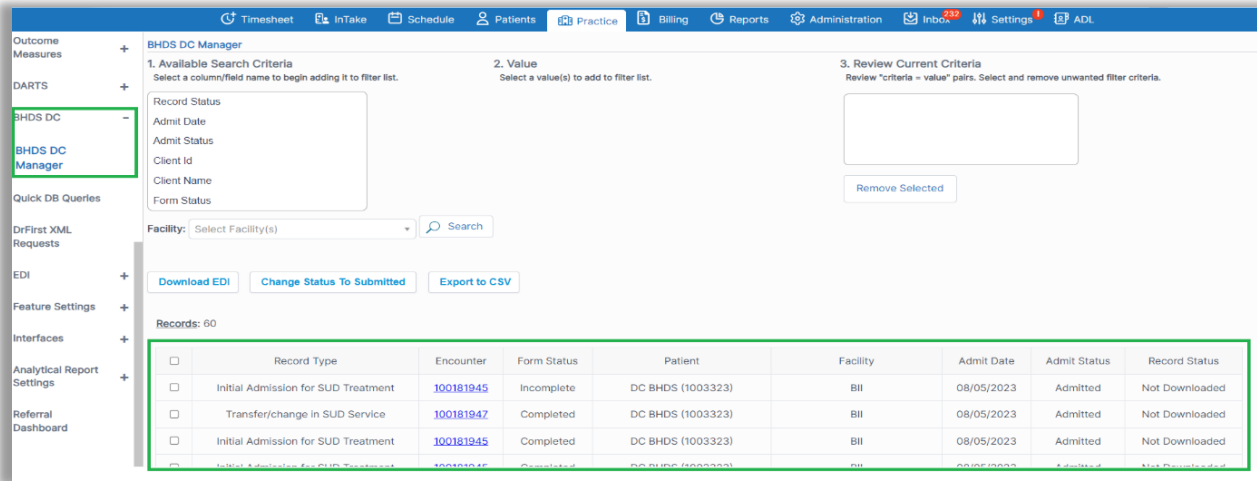

## New Data Submission Interface to Department of Behavioral Health DC

Core Setup

DrCloudEHR now includes a new data submission interface to submit Behavioral Health Supplemental Data (BHSD) Department of Behavioral Health (DBH) District of Columbia (DC). Similar to other state reporting interface, this option is available under Practice->BHSD DC Manager. This option can be enabled per Program/Facility in DrCloudEHR.

A new form, **DC Behavioral Health Supplemental Data**, form is included as part of this interface and is used to populate necessary service/encounter data for submission.



## New Common Medications Module

Core Setup

DrCloudEHR now includes a new setting to enable a pre-set dropdown list of “Common Medications” such as Over The Counter (OTC) medications. Authorized users can manage the list of medications under **Practice->Common Medications**.



During Admission, authorized staff can pick medications that need to be added to Patient Record, eMAR and eTAR. The medication end date is calculated based on Admit Date and the selected duration for each medication defined in Common Medications module.

# Billing

## Updates to Claim Rules and Box 19 of the CMS 1500 (HCFA) Form

Core Setup

DrCloudEHR now includes a rendering provider filter at Claim Rules for CMS-1500 (HCFA) claims. There is an option to insert the data into box 19 on the form.

*E.g., for the provider Test Clinician with ID 999999999, DrCloudEHR will populate "999999999Clinician,Test" in box 19*

**Note:** For this to work correctly, the claims generated must be grouped by Rendering Provider NPI (must use group by option in Claim Rules). If they are not grouped by Rendering provider NPI, services rendered by more than one provider may be populated in the same claim.

## Ability to download 837 batch files

Core Setup

DrCloudEHR now provides the ability to download claims in ANSI X12 format from the Billing Manager. The selected claims can be downloaded as a ZIP file.
