



### New Interactive Reports & Analytics







DrCloudEHR integrates with Power BI to provide insights into practice data with new interactive, graphical analytics reports. Available reports include:

- Executive summary of patients served, units rendered, patients by funding source, and billable amounts based on date and time.
- Expected revenue by insurance type, insurance company, facility, provider, or patient.
- Billable units by insurance type, insurance company, facility, provider, or patient.
- Patient visit counts by payor type, payor, facility, provider, or patient.
- Accounts Receivable based on aging (days past due).
- Use Power BI Desktop to design build reports to add to DrCloudEHR using the Power BI Desktop tool.

# Patient Search

#### **Enhanced Patient Search**







You can now enter multiple search terms in the patient search box to refine your queries. For example, you could type "Smith male" in the search box to retrieve a list of male patients with the last name Smith.




#### Add Address Details to a User's Profile

# Referral Source Tracking & Management





- Incoming referrals can be sent to you via a web based referral form.
- The incoming referrals can be setup to trigger notifications to specified users or groups.
- Referred patients end up in your wait list/applicant area to process like you would all of your other patients waiting to enter services.


## **Expedited Patient Admission Process**

## Calendar Updates









- Click on an empty calendar block to add an appointment
- Drag and drop appointments on your calendar to reschedule
- **Export appointments to Microsoft Outlook**
- You can change the default calendar view to display appointments by day, month, week, or daily agenda.
- When a capacity is defined for a group, the application displays the capacity in the group appointment details.
- Allocate rooms for the appointment

#### Patient Portal Enhancements





We've enhanced security and usability in the Patient Portal.

- When a patient attempts to log in to the portal, and another patient with the same name exists in the system, the application prompts for additional authentication before granting access.
- View and check in for an appointment that is scheduled today.
- View past appointments.
- View upcoming appointments, with an option to export appointment details to Microsoft Outlook.
- The Patient Portal also includes an After Visit Summary page with information useful to the patient, such as the patient's vitals, a list of procedure orders and results, a list of medications, and upcoming appointments.
- Patients can now view and generate their billing statements from the portal.
- Patients can save their e-signature and password so they can digitally sign forms through the portal.

#### **Debit & Credit Card Enhancements**



- We've added support to allow patients to use a debit card to pay for services.
- If you accept credit card payments, we've added an option to reuse a credit card.
   You can also add any relevant notes.



#### Edit Published Form Builder Forms









- Edit Published Forms You can now add fields to a published form created using the Form Builder tool.
  - Notes:
    - You cannot delete or edit any existing fields on the published form when editing
    - You can add new fields to the end of the form
    - You can change the signature permissions settings

# Golden Thread Rule® Updates







- Configure a Golden Thread rule to require that a form be completed every day, instead of every week.
- You can also configure the system to send Golden Thread rule alerts to the care team members and the staff member who either created the form, or is editing the form, in addition to the admitting provider or supervisor.
- You can now define form completion criteria for the New Encounter Form.

# Use Accounting Periods to Manage Transaction Data







- We've added support for accounting periods, which are the date ranges during which transactions are performed. In DrCloudEHR, each month of the year constitutes an accounting period. You can create an accounting period for a specific month, or you can create accounting periods for multiple months in a selected year.

# **Export Billing & Payment Data** to import into Your General Ledger software







 DrCloudEHR now supports exporting data to GL software. This feature works in conjunction with the Accounting Period feature to prevent data import issues.

# Include or Exclude Non-billable Codes in Statements







You can now specify whether to include non-billable codes in the Invoice Details page, in the Statement page, and in statements. If you decide to include non-billable codes, they are shown in separate sections in pages and statements. This is a setting for the entire agency.

# **Enhanced Workflow Support for** Patient Insurance Changes







When a patient changes their insurance coverage, DrCloudEHR notifies you that claims may exist in the system that are pending against the patient's former insurance. You can now choose to update the affected encounters with this new insurance information, reapply any applicable billing rules and reprocess (submit) the claims.

## Fax and Label Improvements



- We've upgraded the Fax Center to support multiple incoming and outgoing fax numbers for a specific facility.
- You can now attach an incoming fax to a specific patient's documents.

# Add Prescription Orders to the Electronic Medication Administration Record (eMAR)



• When a prescription is ordered from an external pharmacy using the DrFirst Rcopia application, the prescription is automatically synced to the ChartMeds electronic Medication Administration Record (eMAR) as a pending medication awaiting prescriber approval. This means that you no longer need to manually add the prescription to the MAR.

## **Needs-based Treatment Planning**







- You can now record a list of needs or problems identified for a patient to track whether a need(s) has been addressed during treatment.
- The Needs list is also displayed in the Patient Summary Chart page for clinical staff's convenience
- Needs are also integrated into the Multidisciplinary Treatment Plan for easy treatment planning
- Needs can be added to Form Builder encounter forms.

#### **New Forms**







We've added two new patient encounter forms:

- Individualized Family Service Plan
- Activity Plan / Progress Note

### **Additional Enhancements**







Here are a few more usability improvements we've made:

- You can add users to the new "Authorize waitlist delete" access control list, which enables you to delete a wait list request from the Wait List Dashboard page.
- You can search for a facility from the Facilities page.
- You can click the new "Log Treatment Time" button in the fee sheet for an encounter to directly access the Encounter Forms Log Time page.
